Data Protection

Thank you for visiting this website. Global Tech Systems places great importance on data security and data protection. Protecting personal rights is integral to our corporate culture and built into our services and products. We respect the safety of your personal data. Global Tech Systems continuously works to improve data security measures to protect you and your privacy. This data protection statement explains what type of information we record when you visit our website, and how we use it. The statement does not apply to websites run by companies that are not part of Global Tech Systems, but who may provide a link to this or any other Global Tech Systems website

Collection and use of personal information

Personal Information includes information we collect automatically when you visit our website. Our web server temporarily records the following information for system security purposes: the domain name or IP address of the computer requesting access, the access date, the client's file request (file name and URL), the HTTP response code, and the website you are visiting from, and the number of bytes transferred over the connection. We may save some information in the form of cookies on your PC. A cookie is a piece of information that a website can send to your browser and save on your system. Cookies do not give us access to your system or your personal data. Please note that standard browser settings allow the use of cookies. If you do not want to allow the use of cookies, you can disable this option in your browser.

We use cookies exclusively to tailor our website to your preferences. We do not collect personal data such as your name, address, phone number, or email address unless you provide this information voluntarily, for example as part of an information request, a competition, a job application, or a request for information about an open position, etc. Personal data collected when visiting Global Tech Systems' website is only used in accordance with the legal requirements applicable in the Republic of South Africa.

Use and transfer of this personal data

We use your personal data only for the purpose of technical website administration and to meet your wishes and requirements, and solely for the specified purpose. Only with your express consent do we use the data for product-related surveys or marketing purposes, and even then, only to the extent necessary for the specific instance. We only disclose data to official agencies if required by law. Our employees are required to maintain strict confidentiality.
